NOTIFICATION

Whereas, the Association of Minority Professional Academic Institutions (representing Sikh minority) has submitted a proposal towards conduct of separate Common Entrance Examinations namely CEE-AMPAI-2025 and CEE-AMPAI-Masters 2025 for admission to (i) 4 years regular B.Tech/B.Pharm courses, (ii) 2 year regular MCA course, (iii) 2 years regular MBA course and (iv) 2 years regular M.Tech and M.Pharm courses for the academic session 2025-26 for the minority institutes under the said Association,

Whereas, the State level Academic Advisory Committee in its Meeting dated 12.03.2025, has examined the proposal of AMPAI dated 06.11.2024. After considering all relevant and material facts and circumstances, the proposal of the AMPAI to hold the above referred Common Entrance Examination for the academic year 2025-2026 is recommended to be accepted, subject to the condition that all directions and instructions of Academic Advisory Committee would be duly and promptly complied with, and compliance report would be submitted before the Committee. AMPAI has to accept the following terms and conditions: -

- 1. For the present, AMPAI is directed to get Security Audit of its Counseling Software done by any Agency approved by the Govt.
- 2. Like previous years, AMPAI has to send last year's question papers to the Expert Member of Academic Advisory Committee for assessment of standard as soon as possible.
- 3. AMPAI may publish Public Notice / Advertisement in a National level and a local reputed newspapers as well as in their respective dedicated examination portal/website.
- 4. After at least 21 days of publication of such notification/advertisement, the date of examination has to be declared.
- 5. The Academic Advisory Committee will send Observer to each Examination Center for monitoring of the offline examination.
- 6. The entire examination and admission process has to be conducted strictly following the guidelines of the Committee and the Committee shall not take any responsibility for any irregularity / malpractice / unforeseen incident, if observed / reported. However, the Nodal Officers of the CEE-AMPAI shall be held responsible for such cases.
- 7. The Committee shall oversee the tests to be conducted by the Association through Observers engaged by the Committee for the purpose.
- 8. The selection of student in the minority colleges through CEE-AMPAI 2025 and CEE-AMPAI-Masters, 2025 should be on the basis of merit only.
- 9. Procedure has to be adopted to keep the standard of question paper at par with the West Bengal Joint Entrance Examinations Board.
- 10. AMPAI shall conduct every step of the examination and counseling process in a fair and transparent manner.
